THE RESEARCH GRANTS DEPARTMENT ADMINISTERS A COMPETITIVE GRANTS PROGRAM, AWARDING THE MOST MERITORIOUS RESEARCH PROJECTS WITH A FOCUS ON THOSE THAT ADVANCE OUR CLINICAL INITIATIVES, TO THE BRIGHTEST SCIENTISTS, TO TRANSLATE THE BEST RESEARCH INTO THE CLINIC.
